

FACTS**WHAT DOES Intercoastal Mortgage, LLC DO WITH YOUR PERSONAL INFORMATION?****Why?**

Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.

What?

The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- **Social Security number** and **Account balances**
- **Payment history** and **Transaction history**
- **Credit history** and **Credit scores**

How?

All financial companies need to share **Customers** personal information to run their everyday business. In the section below, we list the reasons financial companies can share their **Customers** personal information; the reasons **Intercoastal Mortgage, LLC** chooses to share; and whether you can limit this sharing.

What we do

How does Intercoastal Mortgage, LLC protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. **We also use procedural safeguards that comply with Federal standards to guard your non-public personal information.**

How does Intercoastal Mortgage, LLC collect my personal information?

We collect your personal information, for example, when you

- **Provide account information** or
- **Provide employment information** or
- **Give us your wage statements** or
- **Give us your contact information** or
- **Apply for a loan**

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes — information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

What happens when I limit sharing for an account I hold jointly with someone else?

Your choices will apply to everyone on your account - unless you tell us otherwise

Definitions

Affiliates

Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Our affiliates include companies such as Van Metre Companies, Van Metre Intercoastal Mortgage Investment LLC, Walker Title LLC, Walker/Dominion Title LC, MVB Bank Inc., MVB Insurance LLC, MVB Financial Corp & others such as Lenderworks.*

Nonaffiliates

Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Intercoastal Mortgage LLC does not share with nonaffiliates, so they can market directly to you*

Joint marketing

A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Our joint marketing partners include Keller Williams Realty Mclean*

North Dakota residents: In accordance with NDCC section 6-08-1-04, we will not share personal information with non-affiliates either for them to market to you or for joint marketing without your authorization.

Oregon Residents: Intercoastal Mortgage, LLC will not share personal information with non-affiliates for them to market to you without your authorization, and we will not share personal information with affiliates or for joint marketing about your creditworthiness without your authorization.

Vermont residents: Intercoastal Mortgage, LLC will not share personal information with non-affiliates for them to market to you without your authorization, and we will not share personal information with affiliates or for joint marketing about your creditworthiness without your authorization.

Other State Law: Intercoastal Mortgage, LLC follows state law if the state law provides you with additional privacy protections.
